

MEMBERSHIP OF THE TRADITIONAL AND COMPLEMENTARY MEDICINE (T&CM) COUNCIL

Referring to Section 6(1) of the Traditional and Complementary Medicine Act 2016 [Act 775], the Council shall consist of the following members who shall be appointed by the Minister on the recommendation of the Director General:

- a) not more than three (3) representatives from the Ministry of Health;
- b) two (2) representatives from any local universities with expertise in traditional and complementary medicine fields;
- c) not more than three (3) registered practitioners in the public service;
- d) not more than eight (8) individuals from private practice who represent the designated traditional and complementary medicine practitioner bodies in Malaysia; and
- e) five (5) individuals who possess sufficient experience and expertise in the relevant industry

Section 8(1) of the Act 775 states that the Minister may appoint in respect of each member appointed under subsection 6(1) an alternate member who shall be similarly qualified as the member.
